Introduction: Indices of Deprivation 2019

- The Indices of Deprivation 2019 (ID 2019) have been produced to aid the assessment of relative levels of deprivation across England.
- ID 2019 provide scores and ranks for 32,844 Lower Super Output Areas (LSOAs, small areas within a ward) in England for seven main domains of deprivation and for a combined Index of Multiple Deprivation (IMD).
- The seven domains are: Income; Employment; Health Deprivation and Disability; Education, Skills and Training; Barriers to Housing and Services; Crime, and Living Environment. There are also two supplementary indices for income deprived children and older people.
- In Swindon, the rankings go from 1 being the most deprived LSOA to 132 being the least deprived LSOA in the town, and the wards can also be ranked by deprivation.
- Scores and rankings are **relative**. ID 2019 are similar to a league table, and so cannot directly indicate whether a ward has become absolutely more or less deprived over the last five years, but we can state if the trend has been for its score and ranking (in a comparison with all England's small areas and wards) to become better or worse.


Overview of ID 2019 for Swindon UA

- Swindon is relatively less deprived than the average for local authorities and lies in the second least deprived fifth of authorities.
- But there are certainly pockets of deprivation in Swindon. 12 Swindon LSOAs are in the most deprived 10% nationally (compared to 8 in 2015).
- Overall, relative deprivation levels for Swindon as a whole may have increased slightly since the deprivation indices of 2015.
- Within the domains of deprivation the worst ranking for Swindon is Education, Skills and Training although this has seen improvement from the deprivation indices of 2015.
- The Barriers to Housing & Services domain (Housing affordability and distance to local services such as shops and schools) saw the largest deterioration of the domains in Swindon since 2015.



Map of Ward with its LSOAs





ID 2019 Ward Summary: Walcot & Park North

Walcot and Park North Ward - Index of Multiple Deprivation 2019 by National Decile



- Walcot & Park North Ward has a population of around 12,000 which has a greater proportion of young people than the average in Swindon.
- It is the most deprived ward in Swindon. The majority of LSOAs in this ward are all at the relatively more deprived end of the spectrum of LSOAs in Swindon although there are 2 which are around the average.
- The trend has been to a worse score.
- Looking at the domains, Barriers to Housing & Services is the area where this ward is relatively less deprived while Health, and Crime, are where it is relatively more deprived.

ID 2019 Ward Summary: Penhill & Upper Stratton


Penhill and Upper Stratton Ward - Index of Multiple Deprivation 2019 by National Decile



- Penhill & Upper Stratton Ward has a population of around 12,500 which has a higher proportion of older people than the Swindon average.
- It is the second most deprived ward in Swindon, the majority of LSOAs in this ward are all at the relatively more deprived end of the spectrum, including the most deprived LSOA within Swindon, although some are relatively more affluent.
- The trend has been to a worse score.
- Looking at the domains, Barriers to Housing & Services is the area where this ward is relatively less deprived while Education, Skills & Training, and Deprivation affecting children is where it is relatively more deprived.

ID 2019 Ward Summary: Gorse Hill & Pinehurst


Gorsehill and Pinehurst Ward - Index of Multiple Deprivation 2019 by National Decile



- Gorse Hill & Pinehurst Ward has a population of 13,000 which is generally in line with the age profile of Swindon.
- It is the third most deprived ward in Swindon. The majority of LSOAs in this ward are all at the relatively more deprived end of the spectrum of LSOAs in Swindon although there is one which is relatively more affluent.
- The trend has been to a worse score.
- Looking at the domains, Barriers to Housing & Services is the area where this ward is relatively less deprived while Crime is where it is relatively more deprived.

ID 2019 Ward Summary: Liden, Eldene & Park South


Liden, Eldene and Park South Ward - Index of Multiple Deprivation 2019 by National Decile



- Liden, Eldene & Park South Ward has a population of around 12,500 which has a higher proportion of older people than the Swindon average.
- It is the fourth most deprived ward in Swindon. The majority of LSOAs in this ward are all at the relatively more deprived end of the spectrum of LSOAs in Swindon although there are 3 which are around the average.
- The trend has been to a worse score.
- Looking at the domains, Barriers to Housing & Services is the area where this ward is relatively less deprived, while Income deprivation affecting children is where it is relatively more deprived.

ID 2019 Ward Summary: Rodbourne Cheney


Rodbourne Cheney Ward - Index of Multiple Deprivation 2019 by National Decile



- Rodbourne Cheney Ward has a population of around 14,500 which has a higher proportion of older people than the Swindon average.
- It is the fifth most deprived ward in Swindon, the majority of LSOAs in this ward are all at the relatively more deprived end of the spectrum of LSOAs in Swindon, although there are 2 which are around the average.
- The trend has been to a better score.
- Looking at the domains Barriers to Housing & Services is the area where this ward is relatively less deprived, while Health is where it is relatively more deprived.

ID 2019 Ward Summary: Central


Central Ward - Index of Multiple Deprivation 2019 by National Decile



- Central Ward has a population of around 14,750 which is the largest in Swindon and has a lower proportion of older people than the Swindon average.
- It is the seventh most deprived ward in Swindon, the LSOAs in this ward are all at the relatively more deprived end of the spectrum of LSOAs in Swindon.
- The trend has been to a better score.
- Looking at the domains Deprivation affecting children is the area where this ward is relatively less deprived, while Living Environment and Deprivation affecting older people is where it is relatively more deprived.

ID 2019 Ward Summary: Mannington & Western


Mannington and Western Ward - Index of Multiple Deprivation 2019 by National Decile



- Mannington & Western Ward has a population of around 10,000 which has a lower proportion of older people than the Swindon average.
- It is the eighth most deprived ward in Swindon, while one of the LSOAs within the ward is relatively less deprived, there is 1 which is relatively more deprived than the others, while the remainder are around the average.
- The trend has been to a worse score.
- Looking at the domains Barriers to Housing & Services is the area where this ward is relatively less deprived, while Living Environment and Deprivation affecting children is where it is relatively more deprived.

ID 2019 Ward Summary: Lydiard & Freshbrook


Lydiard and Freshbrook Ward - Index of Multiple Deprivation 2019 by National Decile



- Lydiard & Freshbrook Ward has a population of around 11,000 which has a lower proportion of older people than the Swindon average.
- It is the ninth most deprived ward in Swindon. There is a difference within the LSOAs within this ward with 4 being less deprived and 4 being more deprived.
- The trend has been to a worse score.
- Looking at the domains Crime is the area where this ward is relatively less deprived, while Health and Deprivation affecting children is where it is relatively more deprived.

ID 2019 Ward Summary: Eastcott

Eastcott Ward - Index of Multiple Deprivation 2019 by National Decile



- Eastcott Ward has a population of around 10,000 which has a higher proportion of working age residents than the Swindon average.
- It is the ninth most deprived ward in Swindon. While one of the LSOAs within the ward is relatively less deprived there are 2 LSOAs which are relatively more deprived than the others while the remainder are around the average.
- The trend has been to a better score.
- Looking at the domains Crime is the area where this ward is relatively more deprived and Barriers to Services is where it is relatively less deprived.

ID 2019 Ward Summary: Covingham & Dorcan


Covingham and Dorcan Ward - Index of Multiple Deprivation 2019 by National Decile



- Covingham & Dorcan Ward has a population of around 11,500 with about 30% of the population aged 65 and over.
- It is the tenth most deprived ward in Swindon. While most of the LSOAs within the ward are relatively less deprived there are 2 which are relatively more deprived than the others.
- The trend has been to a worse score.
- Looking at the domains Crime is the area where this ward is relatively less deprived and Deprivation affecting children is where it is relatively more deprived.

ID 2019 Ward Summary: St Margaret & South Marston


St Margaret and South Marston Ward - Index of Multiple Deprivation 2019 by National Decile



- St. Margaret & South Marston Ward has a population of around 12,000 with around 27% aged 65 and over.
- It is the tenth most affluent ward in Swindon, the deprivation scores for the LSOAs in this ward are generally around the average.
- The trend has been to a worse score.
- Looking at the domains of deprivation Deprivation affecting older people is the area where this ward is relatively less deprived, and Barriers to Housing and Services is where it is relatively more deprived.

ID 2019 Ward Summary: Wroughton & Wichelstowe


Wroughton and Wichelstowe Ward - Index of Multiple Deprivation 2019 by National Decile



- Wroughton & Wichelstowe Ward has a population of around 9,000 with around a third aged 65 and over.
- It is the ninth most affluent ward in Swindon. While most of the LSOAs within the ward are around the average there is 1 LSOA which is less deprived and 1 which is more deprived.
- The trend has been to a better score.
- Looking at the domains of deprivation, Crime is the area where this ward is relatively less deprived and Barriers to Housing and Services is where it is relatively more deprived.


ID 2019 Ward Summary: Blunsdon & Highworth

Blunsdon and Highworth Ward - Index of Multiple Deprivation 2019 by National Decile




- Blunsdon & Highworth Ward has a population of around 10,000 with around a third aged 65 and over.
- It is the eighth most affluent ward in Swindon. While most of the LSOAs within the ward are around the average there are 2 LSOAs which are relatively less deprived and there is 1 which is relatively more deprived.
- There has not been an obvious trend to a change in score.
- Looking at the domains of deprivation, Crime is the area where this ward is relatively less deprived and Barriers to Housing and Services is where it is relatively more deprived.

ID 2019 Ward Summary: Old Town



- Old Town Ward has a population of around 7,500 with a higher proportion of people of working age than the Swindon average.
- It is the seventh most affluent ward in Swindon. While most of the LSOAs within the ward are relatively less deprived there is one which is relatively more deprived than the others.
- The trend has been to a worse score.
- Looking at the domains of deprivation, Crime and Living Environment are the areas where this ward is relatively more deprived and Education Skills & Training and Deprivation affecting children is where it is relatively less deprived.

ID 2019 Ward Summary: Haydon Wick



- Haydon Wick Ward has a population of around 12,000 with a greater proportion of older people than the Swindon average.
- It is the sixth most affluent ward in Swindon. While most of the LSOAs within the ward are around the average there are 2 LSOAs which are relatively less deprived and there is 1 which is relatively more deprived than the others.
- The trend has been to a worse score.
- Looking at the domains of deprivation, Education, Skills & Training is the area where this ward is relatively more deprived and Barriers to Housing is where it is relatively less deprived.

ID 2019 Ward Summary: Shaw


Shaw Ward - Index of Multiple Deprivation 2019 by National Decile

- The trend has been to a worse score.
- Looking at the domains of deprivation, Barriers to Housing and Education, Skills & Training is where it is relatively less deprived.

ID 2019 Ward Summary: Lawn & Chiseldon

Lawn and Chiseldon Ward - Index of Multiple Deprivation 2019 by National Decile



- Lawn & Chiseldon Ward has a population of around 8,500 with a higher proportion of people aged 65 and over.
- It is the fourth most affluent ward in Swindon. While most of the LSOAs within the ward are relatively less deprived, there is one which is relatively more deprived than the others.
- The trend has been to a worse score.
- Looking at the domains of deprivation, Crime is the area where this ward is relatively more deprived and Health is where it is relatively less deprived.

ID 2019 Ward Summary: St Andrew's


St Andrews Ward - Index of Multiple Deprivation 2019 by National Decile



- St. Andrew's Ward has a population of around 11,500 with around a quarter aged 0 to 19 years.

- It is the third most affluent ward in Swindon. While most of the LSOAs within the ward are relatively less deprived, there is one which is relatively more deprived than the others.
- The trend has been to a worse score.
- Looking at the domains of deprivation, Barriers to Housing & Services is the area where this ward is relatively more deprived and Living Environment is where it is relatively less deprived.

ID 2019 Ward Summary: Priory Vale

Priory Vale Ward - Index of Multiple Deprivation 2019 by National Decile



- Priory Vale Ward has a population of around 12,500 and has a higher proportion of younger people than the Swindon average.
- It is the second most affluent ward in Swindon. While most of the LSOAs within the ward are relatively less deprived, there is one which is relatively more deprived than the others.
- There has been no obvious trend in change in score.
- Looking at the domains of deprivation, Barriers to Housing & Services is the area where this ward is relatively more deprived and Living Environment is where it is relatively less deprived.

ID 2019 Ward Summary: Ridgeway

Ridgeway Ward - Index of Multiple Deprivation 2019 by National Decile



- Ridgeway Ward is the smallest in Swindon and has a population of 3,500 which is slightly older than the age profile for Swindon.
- It is the most affluent ward in Swindon, the 2 LSOAs within the ward are relatively less deprived.
- The trend has been to a worse score.
- Looking at the domains of deprivation, Barriers to Housing & Services is the area where this ward is relatively more deprived and Employment, Education, Skills & Training, and Health are the domains where it is relatively less deprived.
